





#### **EXECUTIVE SUMMARY**

The industrial training has provided me with an experience of how the real

working environment is like. Working for three months in Wilmont Sdn Bhd has

able me to know and understand some of the company's strength and

weaknesses. Problems are discovered in each of the department, especially in

the Shipping Department where I was under the guidance of the Shipping Executive for almost two months. Among the problems known is the lack of employees to help out in the task of this department, no permanent forwarding/shipping company to deal with and the unavailability of a permanent warehouse to store the goods when brought down from Kelantan. Also the company product's price is also a subject of concern along with the Marketing

Department's decisions to mostly concentrate on the international market. On

the operational side, the Quality Control (QC) plan is proven to be not as

effective as it should be causing a lot of returned goods from the buyers. In

addition to that, operational activities being based in Kelantan also pose few

irritants and not using the warehouse/stores in the factory to its limits.

These problems from my idea can be solved by making the price company's

goods more competitive, and also taking proactive steps in developing new

designs and besides that also place more effort to market the products locally.

The shipping department needs more workers to handle the workload available

and also to define the responsibilities in each of the workers' tasks and their

work. Also a proper forwarding company is needed to spare the waste of

unnecessary time spent to look for the most suitable ones. In addition to that a

proper warehouse is needed to make sure that the problem of the unavailability

of them during peak seasons. Lastly, the operational department needs to revise

their Quality Control plans to ensure that defected products will not be

unnecessarily produced. Besides that the move of operations back to Klang is

needed to be done as fast as possible. Lastly the use of inventory spaces needs

to be optimized to better accommodate current needs.

During the training, I took the approach of watch and learn. I was to be taught to

follow the example of my more experienced colleagues when doing certain

tasks. My supervisor has told me that exposure are one the best way to learn,

be it in the working environment or life. Along the three months, I was exposed

to the world outside by participating in the KL Furniture Fair 2002, to the head

factory in Kelantan and also visited the Westport, Klang which is Malaysia's

leading port in handling cargoes and vessels. All these exposures are the effort

by my supervisor to make sure that I really gained knowledge during my three

months internship over at Wilmont. In my opinion the span of three months for

conducting industrial training is too short. There are so many aspects that I have

not fully mastered.

I have discovered that Wilmont is a manufacturing company which specializes in

serving international market. I realized this company has a lot potential to grow

in the future with plans of expansion is underway to build new factories in

Southern Thailand and Klang. The working environment inside the head office, I

found, is very harmonious with close relationships between all of the employees

and also supervisors. This can be seen through lunch time when mostly

everyone will find a place to eat together and chat happily whether its about the
